To drive to school you must register your vehicle in the principal's office. Motor vehicles are to be parked in the student parking lots. Students may not loiter around or be in their vehicle nor leave the school grounds in their vehicle during the school day without permission from the principal's office.

Driving and parking regulations are as follows:

- A. During the school day, student cars are to be parked in the student parking lot in front of the school. *NO STUDENTS MAY PARK ALONG THE CURB IN THE FRONT DRIVE. ALL CARS ARE TO BE PARKED ACCORDING TO THE MARKINGS IN THE PARKING LOT AND ARE NOT TO BLOCK DRIVES.*
- B. *MOTORCYCLES MAY BE PARKED IN THE NORTHWEST CORNER OF THE STAFF PARKING LOT.*
- C. Students are to drive cautiously and responsibly while on school grounds. There is to be NO driving in front of the school during bus loading and unloading. You are never to pass a school bus on school property.
- D. Students who are participating in activities scheduled to begin after school are to leave their cars in the student parking lots.
- E. It is assumed that all vehicles driven by students shall be legally registered, in safe driving condition, and the driver properly licensed.
- F. Students must get permission from the office if it is necessary to go to their cars during the school day.
- G. Any vehicle not usually driven to school by the student but brought because of some special circumstance should be registered for the day in the principal's office upon arriving at school.
- H. Students are not to allow others to ride outside their vehicle at any time.
- I. Students are not to loiter in the parking lot before and after school.
- J. Moving & Parking violations on school property may result in disciplinary actions.
- K. *STUDENT PARKING PASSES ARE REQUIRED TO PARK IN THE STUDENT LOT.*
